## Cr David Eastham - Report for MADCOW 19<sup>th</sup> March meeting

- Interim CEO: Some of you may be aware, our CEO is taking some time off to be with family during a very sad time for them. Tammi has the support of each and every Councillor to do what is needed and take the time that is needed. From an operational perspective we (the Councillors) have been working together to understand what the best interim arrangement is we can make to ensure that the organisation continues to meet the demands of the community.
- Council Plans and Budgets: We are right in the midst of all things Council Plan and Council Budget. This is taking a significant time due to the operating environment we find ourselves in due to COVID. So, there are shifts in budget, priorities and I would imagine that would be felt across the board. I don't have any further information around exactly what that looks like, and we won't until Council agrees on what we're doing in respect to rates, key projects and associated funding streams etc.
- Mandatory training continues: Mandatory training continues for all Councillors under the new Act. This is continuing up into May. Some of the key points are around Child Safe Standards, Gender Equity Act and so on. Some of these new Acts will have an impact on tenders, grant process (which it was already a key element).
- **Hoon driving:** Continues to be addressed both through the work done by Vic Pol and also work that our traffic engineers are conducting relating to anti-social behaviour up on the hill. If you are aware of hooning circuits, loops and so on be interested to pass that on to Vic Pol.
- Local Roads: Continues to be a major issue out in Monbulk and surrounds. Also, the impact of some of the road sealing that has occurred over recent years. So as a result of the significant weather we've experienced it's highlighting some engineering issues which I'm working with Council officers to resolve.
- Olinda/Philip Johnson: \$2.8m to replicate Chelsea Flower Show in 2013.
- **Covid** Council continues to support the community in relief and recovery from Covid. This does include reallocation of resources to ensure that Council supports the broader Yarra ranges community as best as possible.
